### NARRATIVE

ON MONDAY JULY 5, 2010 AT APPROX 2130 AN UNKNWN SUSP ON A MOTORCYCLE KICKED THE COMP PASSENGER SIDE MIRROR OF HIS LISTED RANGE ROVER AND CAUSED DAMAGE APPROX 500.00 DOLLARS WORTH. COMP STATED WHILE DRIVING SB ON THE DALLAS NORTH TOLLWAY A WHITE FORD PICKUP TRUCK CAME UP NEXT TO HIM IN THE OUTSIDE LANE AND PACED HIS SPEED WHILE A GROUP OF MOTORCYCLES CAME UP BEHIND THEM AND ONE OF THE MOTORCYCLE "WHITE LINED" BETWEEN THE TWO VEHICLE AND WHILE PASSING THE COMP VEHICLE KICKED THE PASSENGER SIDE MIRROR CAUSING DAMAGE TO THE MIRROR AND THEN DROVE OFF AT A HIGH RATE OF SPEED. THE DRIVER OF THE LISTED FORD "FLIPPED OFF" THE COMP AND LAUGHED AT HIM WHILE THE MOTORCYCLE DROVE BETWEEN THEM. THE COMP STATED TO RO THAT THE DRIVER OF THE FORD MAY HAVE BEEN THE RING LEADER OF THE GROUP OF MOTORCYCLES. COMP STATED THAT HE JUST WANTED TO REPORT THIS TO POLICE SO THAT THEY WOULD KNOW ABOUT THE INCIDENT. THE COMP ALSO TALKED TO THE DEPARTMENT OF PUBLIC SAFETY STATE TROOPER THAT WAS ON THE TOLLWAY TO NOTIFY THEM OF THE "RASH" ACTS THE MOTORCYCLES WERE CAUSING. END OF ELEMENTS.
